Performing Company Production Agreement

We are so excited to bring the performance of the **Wizard of Oz** back to our recital stage and we would love to invite your dancers to dance down the yellow brick road and be a part of the magic!

To have a successful and enjoyable year, it is imperative that we set forth rules and guidelines expected from your dancer to be a part of this production. Your teacher has agreed to dedicate berself, but time, and her talent to greate special pieces.

To have a successful and enjoyable year, it is imperative that we set forth rules and guidelines expected from your dancer to be a part of this production. Your teacher has agreed to dedicate herself, her time, and her talent to create special pieces of choreography for you. She has high expectations that can only be reached if every member is dedicated and brings positive energy and demonstrates teamwork. The guidelines are as follows:

- Your child is allowed a total of 4 unexcused absences throughout the year for their production class. After the 4th unexcused
 absence, your child will need to schedule a private lesson based on teacher's availability. If you incur more than 3 private lessons
 due to absences, your child may not be able to continue to participate.
- The only excused absences are religious holidays, graded school activities, and illnesses with a doctor's note. All other absences are unexcused.
- Long term illness or injury must be discussed with your child's production teacher.
- To participate in the production, your child must take the correlating combo class. Combo class is mandatory and must be attended on a regular basis.
- All students in grades 6-12 must attend 30 ballet, pointe, or jazz technique classes throughout the year. Students in grades 3-5
 must attend 30 combo classes a year. (if dancer is on a competition team this production requirement is satisfied through
 competition team requirements)
- Deadline to audition is June 1st. No auditions after this date will be permitted.
- It is the dancer's responsibility to be at class on time.
- Dancers must participate in the summer camp: Dance Splash. Camp begins the week of July 15th. All dancers must attend at least 4 classes.
- Dancers must also participate in our Jump Start classes this summer. All dancers must attend at least 4 classes.
- Additional practices may be added on Saturdays, with the expectation that all dancers will do their best to participate!

Financial Commitment is as follows for the school year:

- Production Dancers add \$10.00 per month to monthly tuition.
- A \$50.00 costume deposit must be received with the Performing Company Agreement form. This will be applied directly to your costume fee in the fall.
- Register for Summer Splash Dance Camp and the Jump Start Summer Camp, before or with the production Agreement Form.
- Depending on the role received, there may be requests for additional private lessons to help with choreography. This will be at additional private lesson costs.

Please carefully read this agreement before signing. Both parent and dancer must sign the agreement and return it by June 1st. If not returned, it will be assumed that you are not interested in being a member of the Performing Company.
